Key Business in 2013-2014 (I)

Awards

Key Business in 2013-2014 (II)

Handbook for Cognition and Assessment

Jackie Leighton and André Rupp proposed a co-edited Handbook of Cognition and Assessment to Wiley-Blackwell. The contract got signed in March 2014 and work on the handbook has commenced! It is scheduled for publication in 2016 and, while not a 'SIG publication' per se, has many contributions by SIG members.

The handbook will be a solid stepping stone for the creation of a SIG Journal for Cognition and Assessment, which would be one desirable follow-up goal for the SIG (probably under the purview of my successor).
